2. In respect of category applied for, all intended contractors will have to make prescribed security deposit in the form of bank instrument in favour of "The Director NIT Manipur" payable at Bank of Baroda Langol

within 30 days of issue of this letter.

3. In the event of black listing or any objection from the parent registered department/agency, the empanelment of the contractor in the institute will automatically be terminated without any prejudice and without any prior

4. The initial empanelment period is for five years, however, the contract validity may be extended or may be reduced subject to the performance of the contractor and at the discretion of the competent authority.

5. The security deposit amount is non-refundable and non-transferable for the empanelled period.

6. The competent authority will have the absolute right to decide work execution either through institute's engineering cell or on deposit basis to other agency without assigning any reason thereof.

7. In case of any dispute/ambiguity that may arise in the said empanelment process, the decision of the competent authority of the institute will be final and in case of any litigation, the court/tribunals within the territory of the state of Manipur shall have exercise jurisdiction.
