TEQIP-III sponsored minor research grant

Guidelines

1. Regular faculties of NIT Manipur may apply in the prescribed format for the minor research grant sponsored by TEQIP-III.
2. The research award is up to Rs. 2,00,000/- depending on the proposed budget.
3. Selection will be based on the recommendation from selection committee.
4. Maximum 25% of total budget allocation may be booked for purchasing minor equipment. Purchase of major equipment and international travel are not supported in the project.
5. No credit point for sponsored project (8 credit points) can be claimed based on this project.
6. Total duration of the project is 6 months.
7. 25% fund will be allocated as the first instalment and SE/UC will be submitted after 90 days. Remaining 75% fund will be allocated after submission of SE/UC.
8. Awardee has the sole responsibility to submit final project report along with SE/UC within 15 days of completion of the project.
