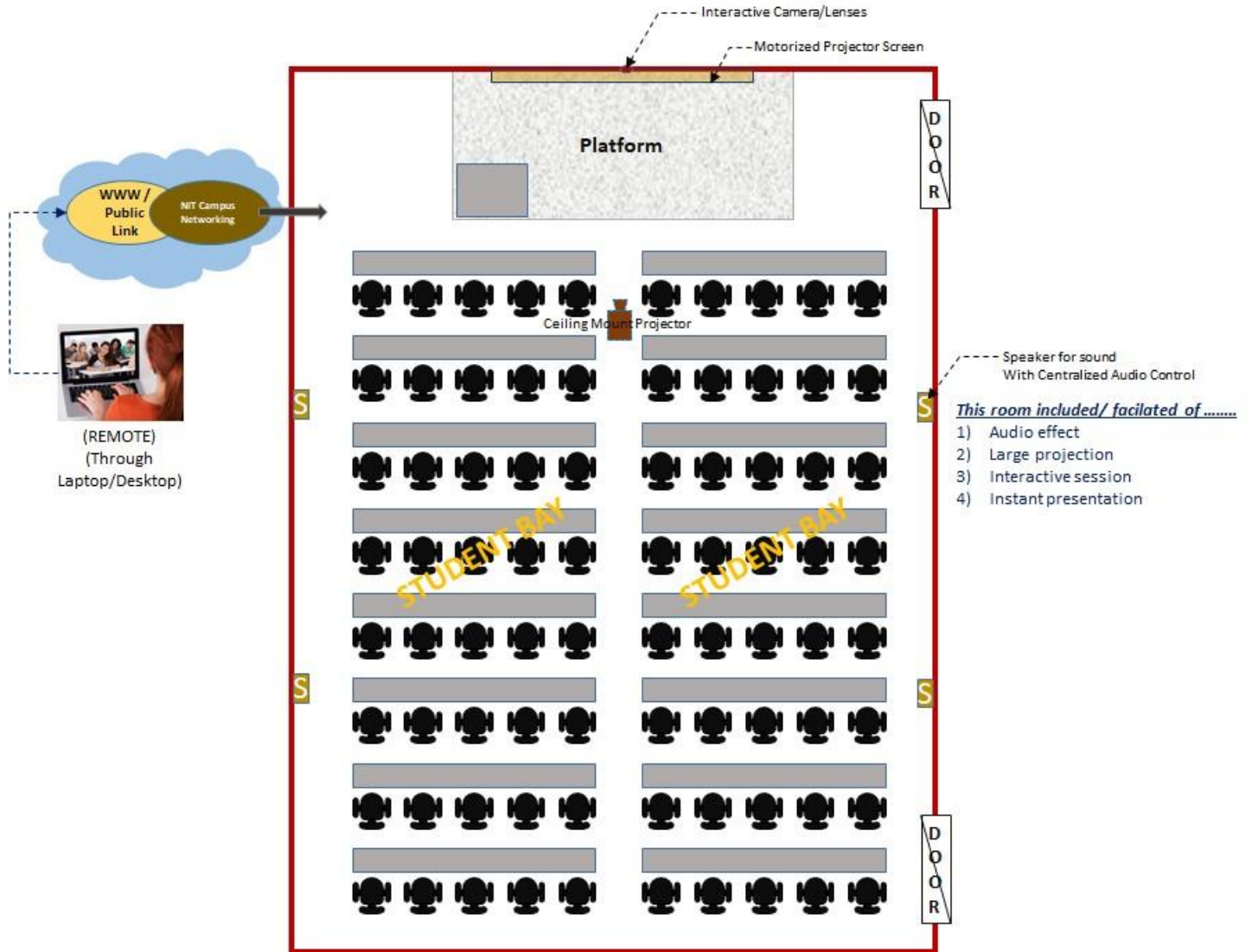


TENTATIVE SCHEMATIC DIAGRAM

MANDATORY ELIGIBILITY CRITERIA OF THE OEMS

Sl. No.	Eligibility Criteria (ACTIVE OEM)
01	OEMs of proposed equipment/components should have their own registered office in India as per the prevalent/ applicable laws of India and be in operation in India for last five years as on the bid issuance date.
02	Registered offices by way of Joint ventures, Franchise, agency, distribution partners will not be considered.
03	OEM Installation Base- Should have installed 10 times (Min.) of quoted items within last 5 Years.
04	OEM should have quality standard certifications like ISO 9001-2008/ISO 14001/ ISO 27001, wherever applicable to ensure only quality OEM participation, as on date of RFP release
05	Proposed OEM for any technology should not have filed for bankruptcy.
06	All offered Switching components must be ROHS compliant. ROHS compliance shall be mentioned in datasheets.
07	The proposed OEM should not have been blacklisted by any State / Central Government Department or Central /State PSUs
08	OEM should be certified/ approved/ patented by Indian/International standardization system.
09	OEM should have minimum 1 spare depots in India for hardware replacement and dedicated TAC Support center in India.

01	Passive Component's OEM offered must be in steady profitable business in India for more than at-least 10 years.
02	OEM should have ISO 9001:2015 and ISO 14001 certified manufacturing facility in India or any similar type of certified manufacturing unit.
03	OEM shall have at-least 2 certified technical staff based out of India.
04	All offered components must be ROHS compliant. ROHS compliance shall be mentioned in datasheets.
