**NOTE: The number of vacant seats for all the discipline will be announced after the central counseling for MTech (CCMT-2015) results are declared completely by 15<sup>th</sup> July.**

### 1. INSTRUCTION:

Candidates are advised to fill the application **ONLINE**, and upload all the relevant documents (scan).

3. Certificate of Date of Birth issued by competent authority or Class X (High School Board) Certificate as proof of date of birth.
4. Mark Sheet of Class XII.

6. Degree / Provisional certificate of qualifying degree.
7. Certificate of Social Category (OBC/SC/ST), if applicable, as per Government of India, issued by the competent authority. In case of OBC category, the certificate must be issued on or after April 1, 2015
8. Experience Certificate (if any)
9. NOC.

**Only the shortlisted students have to deposit the application fees through online/NEFT, the amounts and details of which will be intimate by 15<sup>th</sup> July 2015.**

No accommodation shall be provided during the admission test. The candidates may provisionally book journey tickets for admission test and admission in advance to avoid its non-availability after the publication of the lists. Respective departments shall be entirely responsible for the selection process and all queries related to admission should be directed to them only.

### 4. ELIGIBILITY

**M. TECH. PROGRAMMES:** At least **60% marks (6.5 CGPA)** in (last qualifying degree examination); **relaxation of 5% marks / 0.5 CGPA is applicable for SC/ST candidates.** If the results of the last qualifying examination are not published yet, the qualifying marks are applicable till the last semester.

The reservation will be as per the vacancy available after the centralised counselling (CCMT-2015).

## **5. ADMISSION PROCEDURE FOR M.TECH PROGRAMMES (WITHOUT SCHOLARSHIP)**

**Mere eligibility will not ensure a call for admission test and/or viva voce.** Depending on the number of applications received and the eligibility, a shortlist shall be prepared for a call for admission test. A further screening shall be made after the written test and the list of candidates to appear for viva voce will be published after the admission test.

- (i) 30% weightage on Percentage of Marks / CGPA obtained in the last qualifying examination, 30% weightage on written Admission Test, and 40% weightage on viva-voce in respective departments at NIT Manipur.
- (ii) Sponsored candidates must have a minimum of **two years** full-time work experience in a registered Firm/ Company /Industry /Educational or Research Institutions/ any Government Autonomous Organizations in the relevant field in which admission is being sought. For NIT Manipur staff this rules are exempted but to be admitted as part-time candidate. A letter from the Employer must be furnished along with the application stating that the candidate is being sponsored to get admission. The Employer should also indicate that the candidate will not be withdrawn midway till the completion of the programme and will not claim for a job through Campus interview at NIT Manipur.
- (iii) A **No-Objection Certificate** from the employer is essential for admission to M Tech programme for a **part-time candidate** and their working place must be within 30 km from NIT Manipur.

## **6. HOSTEL**

Hostel accommodation may be allotted for the full-time students **subject to availability**. However, there is an acute shortage of hostel accommodation presently.

## **7. CANCELLATION OF ADMISSION**

Refund of fee due to the cancellation of admission will be made as per the rules of MHRD, Government of India and the Institute subject to submission of application with all relevant documents.
