
## **CIRCULAR**

The academic session will start from 26<sup>th</sup> August 2025 onwards.

Students are advised to bring the following original documents during the physical reporting process at NIT Manipur.

- 1. Class X Mark Sheet/Certificate or Birth Certificate (for Date-of-Birth).
- 2. Class XII Mark Sheet (Qualifying Examination).
- 3. Photo ID proof as per Govt. of India norms, especially Aadhaar Card.
- 4. JEE (Main) Score Card.
- 5. Provisional Admission Letter (Final) issued by JOSAA/CSAB 2025.
- Certificate of category (SC/ST/OBC-NCL/GEN-EWS), if applicable [in the format available on the JOSAA/CSAB-2025 website, issued by the competent authority]. In case of OBC-NCL/GEN- EWS category, the certificate must be issued on or after 1st April 2025.
- 7. In case of PwD category, Physical Disability Certificate as per JOSAA/CSAB 2025 format.
- 8. Family Income Certificate (if applicable), issued on or after 1st April 2025 by an officer, not below the rank of Tehsildar in the States/UTs.
- 9. Medical Certificate as per JOSAA format.
- 10. Copy of the Online Payment receipt for the Balance Fee Payable to the Institute for 1st Semester (if applicable).
- 11. Undertaking Affidavit by Parents/Guardian (On Anti-Ragging) (To be given on Non-Judicial Stamp paper of minimum Rs.100/- and duly notarized).
- 12. Undertaking Affidavit by Student (On Anti-Ragging) (To be given on Non-Judicial Stamp paper of minimum Rs.100/- and duly notarized).
