

Minutes of the Steering Committee Meeting regarding PM-YASASVI

Top Class Education in Colleges for OBC, EBC and DNT students.

A Steering Committee meeting was held under the chairmanship of Secretary, Department of Social Justice & Empowerment regarding the Central Sector Scheme of Top Class Education in Colleges for OBC, EBC and DNT Students at 12:00 Noon on 17.06.2025 in New Conference Hall, Room No. 627, A-Wing, Shastri Bhawan, New Delhi. A list of participants has been placed at Annexure-A.

2. Secretary, SJE and Chairman of Steering Committee welcomed the participants and after introduction of participants, Joint Secretary (BC) made a presentation depicting an in-depth analysis of the Scheme performance for the last 2 years primarily focusing on major institutions which are gaining prominently by utilization of 100% allocated slots and also on the institutions which have not utilized allotted slots. The members deliberated on the institutions to be covered under the scheme and distribution of available 21962 slots (including renewal) for institutions for the year 2025-26 such that full utilization of allotted budget available in FY 2025-26 could be achieved.

3. The following points emerged during the meeting:

i. Ministry of Civil Aviation:

As far as inclusion of Commercial Pilot Training Courses and institutions under the Ministry of Civil Aviation/Flight Institutes is concerned, it was stated that the scholarship amount is a considerable amount as compared to other scholarships and beneficiaries are very less. Ministry of Civil Aviation (MoCA) suggested that CPL training Institutes may be considered for scholarship to the extent possible that the top scholarship amount available for any Government Institute may be taken as the upper limit to be disbursed to the applicants applying under CPL courses. It was decided that the matter will be examined

separately for consideration.

As regards a proposal to add other courses from Rajiv Gandhi National Aviation University (RGNAU), it was decided that MoCA will submit a proposal for consideration of the Ministry as these are administrative matters.

ii. Ministry of Health and Family Welfare (Medical Education):

Secretary, SJE has pointed out about the low turnout of applications from some of AIIMS Institutions. Director, MoHFW (Medical Education) stated that there is nominal fee, etc in AIIMS and that might be the reason. Chairman requested the representative of the MoHFW, Medical Education to look into the matter and sensitize the Institutes for larger participation for the benefit of the targeted group under the Scheme._

iii. Department of Higher Education:

Department of Higher Education was requested to take necessary action on the insights shared during the presentation as the scheme caters to Top Institutes which primarily come under the domain of Department of Higher Education.

4. During the course of discussion, Chairman also raised the following points for consideration.

(i) Concern over the delay in disbursal of scholarships to the beneficiaries in 2024-25. It was informed to the Chair that the Division is resorting to the information in Annexures from Institutes as the Institutions are verifying more number of slots than allocated slots. This is primarily to decide upon inter-se ranking among the applicants as per slots. Chairman directed to make effective mechanism such that a timeline may be fixed for real-time disbursal of scholarship to the targeted beneficiaries.

(ii) Chairman has also enquired about the opening of the Portal for inviting applications from the Students. It was informed that authorities of DBT Mission and National Scholarship Portal finalise the timelines for invitation of applications and closing date. Chairman desired to make live the Portal before the Academic Session starts so that the beneficiaries can avail the scholarship benefit in real-time. It was informed that the matter will be taken up with the DBT Mission in this regard.

(iii) It was also decided that the list of Institutes will be shared with the participant Ministries/Departments such that they may make an awareness about the scholarships for targeted groups and thereby enhancing the performance of the Scheme.

5. After discussions, the Steering Committee headed by Secretary, SJE gave the following decisions for:

(i) Distribution of available 21962 slots (including renewal) among 304 institutions.

(ii) 40% increase in slots for institutes.

(ii) Allocating nominal number of slots (2-3) to the institutes whose performance is not satisfactory or Institutions where sufficient number of applicants have not applied in the last two years.

(iv) Increase of 3 slots to the IIM, Sirmaur for the year 2024-25.

(v) Steering Committee may meet again after the closing date of the NSP and examine and decide reallocation of slots, if any remain vacant, based on the number of applications received from the institutions.

The Meeting ended with a vote of thanks to the Chair.
