- The other economically backward students (whose family income is between Rs. 1.00 lakh to Rs. 5.00 lakh per annum) shall get remission of 2/3rd of the tuition fee. (For B.Tech students only)

SC/ST students who are eligible for any kind of scholarship aid which incorporates the tuition fees from the central/state Govt./Ministries must submit an undertaking to deposit the tuition fee amount with the Institute as soon as they receive the scholarship amount as per the letter No. F.14-5/2013-SC/ST dated 13/01/2014 of Ministry of Human Resource Development, Govt. Of India.


