

Minutes of the 19th Finance Committee meeting by circulation dated 08/04/2020

The 19th Finance Committee meeting and the 19th BoG meeting of the Institute were scheduled on 27/03/2020 at Conference Hall, NIT Transit House, 15, Block C, Panchsheel Enclave, New Delhi-110017. Detailed Agenda items along with Annexures of both the meetings were circulated to all the FC/BoG members on 08/03/2020. Due to the prevailing situation of COVID-19 pandemic and the subsequent lockdown, the above meetings were deferred. The deferment of the above meetings was also intimated to all the members on 16/03/2020.

As the 3rd quarter of the AY 2020-21 was over, the State Project Administrator, SPIU-NE had suggested that the BoG meeting may be conducted through Video Conference at the earliest. Otherwise SPIU shall not be able to comply with this DLI and reimbursement from the World Bank would not be possible.

After due communication with the State Project Administrator, SPIU-NE and ADG, MHRD, it was agreed to conduct the BoG (Emergency) by circulation and subsequently the BoG agenda were circulated to all the BoG members vide Letter No. NITM.1/(22-Estt)/BOG/2018/76 dated 08/04/2020 for kind consideration and approval by circulation.

The Finance Committee meeting (Emergency) by circulation adopted the resolutions on the following agenda as under:


