


ITEM NO. 31.6: Report on Pending grievance issues.

The 31st BoG noted that there are three pending grievance issues. However, the Board was informed that two grievances have already been disposed of. The Board also suggested for early disposal of the pending grievance.

ITEM NO. 31.7: Latest position of unspent balance as on 9th January, 2023.

The 31st BoG noted the unspent balance as on 9th January, 2023.





ITEM NO. 31.8: To approve the advertisement for recruitment of non-teaching staff.

The BoG approved the advertisement of the vacant positions of non-teaching staff as per the reservation roster. The Board also noted the inclusion of one time age relaxation upto 56 years for existing contractual staff as approved earlier by the 17th BoG in the advertisement.

ITEM NO. 31.9: To approve for release of advertisement of vacant faculty positions.

The BoG approved for releasing of advertisement of the vacant positions of faculty as per the format of the previous advertisement approved by the BoG in its 28th BoG. However, the Board suggested that the clause "Internal Candidate" should be removed from the advertisement.


ITEM NO. 31.10: Detailed report on Shri Samarjit Singh, Executive Engineer.

The BoG perused the case of Shri Samarjit Singh presently serving as Executive Engineer in NIT Manipur through the PPT presentation highlighting the chronology of events beginning from his initial recruitment till regularisation of his service and the ongoing Court case regarding regularisation of his service in NIT Manipur in the Hon'ble High Court of Manipur. The BoG deliberated in length the matter regarding his absorption as regular employee when he had joined on deputation basis inspite of his regular appointment as mentioned in the advertisement. The BoG also noted the observation made by the Deputy Solicitor General of India, High Court of Manipur dated 16th September 2022 and the letter dated 19th January 2023 wherein he has opined that an additional affidavit may be filed for substantiating the case which was placed in the Annexure and to write a letter to his parent organization. The BoG found that there have been several discrepancies at various stages starting from the recruitment process and suggested the need for a detailed investigation in the matter. The 31st BOG recommended that the Institute should follow up the pending Court Case after discussion with the Deputy Solicitor General of India, High Court of Manipur and refer the matter to the Ministry of Education.

ITEM NO. 31.11: To discuss on the effective date of joining for faculty members.

The BoG noted the approval of the recommendation of the Selection Committee for appointment of 25 nos. of faculty members in the 30th BoG. The Board was apprised that as per the Ministry's directive, the offer letters were uploaded in the Ministry Recruitment portal on 24th November, 2022. The offer letters were kept on hold pending Rozgar Mela as directed by the Ministry leading to subsequent delay in joining date. Since no Rozgar Mela was held during the month of December 2022, the offer letters was issued to all selected candidates on 26th December, 2022 in a local Rozgar Mela held in the Institute. The Board after deliberating on the circumstances leading to the delay in formal joining dates, the BoG approved the proposal for considering the date of approval of the recommendation by BoG i.e. 21st November 2022 as the effective date of joining for the internal candidates.

However, for the new candidates, the effective date will be taken from the date of joining.

Prof. Uday Shanker Dixit Member, BoG has given his observation that reference to Rozgar Mela should not be mentioned as it is not a regular event and should not become precedence.

ITEM NO. 31.12: To discuss grievance issues related to promotion for non-teaching staff.

The BoG noted the proposal for sanctioning of various non-teaching positions for promotional avenues submitted to the Ministry. The BoG suggested that a fresh proposal with proper justification may be submitted to the Ministry.

ITEM NO. 31.13: DPC result for financial upgradation of Non-Teaching employees.

The Board in principle approved the recommendation of the duly constituted DPC Committee for financial upgradation of Dr. Naorem Vidyavati Devi, Assistant Librarian from Rs. 6000 to Rs. 6600 Grade Pay. The Board also noted the recommendation of the DPC committee of Shri Laikangbam Dorendro Singh, Assistant Registrar which has been kept under sealed envelope. However, the Board advised that the format of the minutes be modified in the standard format for DPC and placed in the next BoG for ratification.

ITEM NO. 31.14: Status of filling up of vacant position of teaching and non-teaching members.

The BoG noted the vacant position of teaching and non-teaching positions and advised that necessary steps should be taken up to fill the vacant posts.

ITEM NO. 31.15: Proposal for release of Dr. Yumnam Rohen Singh, Associate Professor, Dept. of Mathematics on lien to Manipur University.

The Board approved the proposal for release of Dr. Yumnam Rohen Singh along with that of Dr. Dushyant Singh on lien initially for 1 year so as to enable them to join their new organization:

The Board noted the Audit Report for the year 2021-2022 submitted by the Principal Accountant General (Audit). The BoG advised that the same along with the Annual Accounts and Annual Report for 2021-2022 should be submitted to the Ministry within January, 2023 for placing the same in the Parliament.
