The Registrar presented a brief report of Shri Samarjit Singh, Executive Engineer, who joined on 24/04/2015 as deputation against the regular advertisement for the post of EE and others vide number NITM.1/(2-Estt)/MP/2010/275 dated 12/10/2010. He was permanently absorbed after three years, two months, and three days vide letter number No. NITM.21/Engg/Per/2015-16/ date 26/06/2018 without BOG approval. The 14<sup>th</sup> BOG Meeting held on 20/12/2018 recommended that the absorption cannot be done and directed the writing of a letter to the parent organization to take back the Shri Samarjit Singh, Executive Engineer. Presently, the matter is in the Hon'ble High Court.

**RESOLUTION:**

The Board noted the report on the Court case of Shri Samarjit Singh, Executive Engineer and directed the NIT Authority to proceed as per Court directives.

**Item No. 36.8** To consider and approve debarring Mr. Laikangbam Dorendro Singh, Assistant Registrar, NIT Manipur, from all official works until the CBI case is over and for taking appropriate decisions.

The Registrar presented that FIR No. RC 3(A) 2016-IMPH dated 29/09/2016 was registered by CBI, ACB, Imphal, against Mr Laikangbam Dorendro Singh, Assistant Registrar, NIT Manipur, for committing alleged criminal offence relating to possession of property disproportionate to his known sources of income.

In this regard, various decisions taken by the BOGs and subsequent orders by the Institute are placed at ANNEXURE.

However, all sensitive files were still moved or processed through him, although he had already been charge-sheeted by the Anti-Corruption Bureau, CBI, Imphal, for the commission of alleged criminal offence relating to the possession of property disproportionate to his known source of income.

It is against the sanctity of the Institute to process such sensitive files through the said charge-sheeted employee, being already charge-sheeted in a corruption case by the ACB, CBI, Imphal.

It is also put forth that in many incidents, the said employee (in disguise as an outsider) has been writing many letters to different organizations, including the



senior officials of the Institute and also to the Institute, to tarnish the image of the senior officials and the Institute. He has the obnoxious, unusual practice of recording unbecoming remarks and noting in the files, comments in the files, making aversive questions to his senior officials and Authority. The concerned employee has been repeatedly advised and directed to rectify his attitudes and maintain official protocol, decorum and etiquette while processing file records noting and performing his duties as a Government employee. The concerned employee has deliberately failed to pay any heed to the above advice, and till date, he continues to record such unbecoming comments and aversive questions to his senior officials and Authority, with impunity. Recently, he has directly and personally questioned the integrity of the Director in the file noting. Intentionally, he has not performed the jobs and tasks assigned to him seriously and failed to take any responsibility seriously, as entrusted to him by the Institute.

In one such instance, recently, the said employee failed to perform sincerely, earnestly and diligently the task of preparing the draft Annual Report and Audited Account for 2022-23. He was assigned the task of preparing the draft Annual Report and Audited Accounts 2022-23. The concerned employee deliberately copied from the previous Annual Report 2021-22 data and submitted it to the Registrar's Office. Fortunately, the Registrar's Office intervened and avoided the catastrophe of submitting the wrong Annual Report and Audited Account for 2022-23. The delay caused in submitting the Final Annual Report and Audited Accounts 2022-23 to the Ministry is because the said employee deliberately prepared the wrong Annual Report and Audited Account for 2022-23 copied from the previous Annual Report 2021-22 data. Due to his unruly behaviour, conduct, and unbecoming of a public servant, as well as, his deliberate act of continuing making unbecoming comments in the files, official sensitive files have not been sent to him for processing for the last about six months or more to avoid creating more problems for the Institute.

To consider and approve debarring Mr. Laikangbam Dorendro Singh, Assistant Registrar, NIT Manipur, from all official works until the CBI case is over and for taking appropriate decisions.

#### RESOLUTION

After a thorough and transparent deliberation and a meticulous examination of all material facts and documents on this item, the Board has unanimously resolved to recommend the immediate implementation of the following decisions:

- (i) To conduct disciplinary proceedings against Mr. Laikangbam Dorendro Singh, Assistant Registrar, a regular employee of NIT Manipur, in regard to the charges levelled against the said person of indiscipline, insubordination, misconduct, dereliction of duty and conduct unbecoming of a public servant.

At this juncture, the contemplated disciplinary proceeding will not be in relation to criminal charges already framed in respect of FIR No. RC 3(A) 2016-IMPH dated 29/09/2016 registered by CBI, ACB, Imphal, against Mr Laikangbam Dorendro Singh, Assistant Registrar, NIT Manipur and currently pending in a criminal trial.



(ii) In view of the contemplation to initiate disciplinary proceedings against Mr Laikangbam Dorendro Singh, Assistant Registrar, NIT Manipur, he may be placed under suspension under the provisions of CCS(CCA) Rules, as per law, immediately.



The vacancies considered for mapping will be flexible with the same cadre only. After mapping, employees will be considered for promotion at one stage above the feeder cadre.
