## Item No. 40.9

To consider and to approve the recruitment of vacant Teaching and Non-teaching posts.

a) Teaching posts: vacant positions of teaching posts at various levels of the Assistant Professor cadre were advertised in November 2024 with the approval of the Board.

Institute could not complete the recruitment on or before 31.1.2 2024. In addition, some of the existing faculty working on contractual basis were approached legally and Court directed to protect the existing faculty working on contractual basis up to 7.1.2025. Institute re-advertised for 16 Vacant posts (level 12 (3 nos) and Level 10 (13 Nos)) in various departments by following the roster. The dead line for receiving applications is 5<sup>th</sup> January 2025. In view of these, it is requested to complete the faculty recruitment by the end of February 2025.

b) Non-Teaching Posts: Preparation of advertisement by following the roster for various vacant posts of Non-teaching posts in in progress and proposed to release the advertisement in the first week of January 2025. Members of the Board is requested to initiate and complete the recruitment of non-teaching posts by the end of March 2025.

#### **RESOLUTION:**

- a) Upon deliberations, the following are the decisions taken in connection with teaching staff recruitment:
  - i) Approved to protect the term of existing faculty working on contractual basis up to 7.1.2025.
  - ii) Approved to complete the faculty recruitment on or before end of February 2025.
  - iii) Authorize the Director to review the workload of each department and permitted to appoint visiting faculty on hourly basis if needed on temporary basis for the second semester of the academic year 2024-25.
- b) Approved to advertise vacant non-teaching posts and complete the recruitment by the end of March 2025.
