
The proposal should include and follow the guidelines below for the evaluation and consideration by Institute level committee.

- Objectives of the Proposed Topic
- Tentative lists of Experts for the proposed course
- Tentative Schedule for the FDP program
- Expected outcomes from the proposed FDP program

Preference for the conduct of the FDP will be given to those proposals where the FDP topics are in line with the topics suggested by AICTE (as per the list given below).

1. Examination reforms
2. Mentor's Training as per the norms of NITTT.
3. Cognitive skills & Design thinking.
4. NBA Accreditation & the processes.
5. Identifying problems & double diamond approach towards design
6. Model curriculum as prescribed by AICTE.
7. Induction program for students as prescribed by AICTE
8. Intellectual property management at early stage of innovation & start - ups
9. Frugal innovations & social entrepreneurship

It is to be noted that preference may be given to those departmental faculty members who have not conducted the AICTE-NIT FDP program in the last FY 2020-21.
