The Senate was apprised that Ph.D scholars have been registering in any of the existing department by the Dean (AA).

ITEM NO. 13.10: **Miscellaneous**

1. **Discussion to allow UGC approved journals prior to the effect of UGC care list as the criteria for submission of Ph.D thesis**

The Senate recommended for allowing UGC approved journals listed in the UGC website for submission of Ph.D thesis subject to review by expert nominated by the competent Authority.

2. **Discussion regarding the caution money for M.Sc students**

The Senate recommended in taking caution money from M.Sc students from the next academic session.

3. **Detention/promotion of 14 students of B.Tech programme. The list of students is placed at [Annexure 13.9]. Students to be promoted and to be detained were approved by the Chairman, Senate as a special case and the same is placed in the Senate for kind ratification.**

The Senate ratified the proposal. The senate recommended for conducting special exam or make-up exam for students getting F-grade in subjects before the admission/registration.



4. Discussion on the case of Mr. Sunil Kumar Yadav who is presently working as GET-AME in Engineering Department, AIESL, Chennai. He got admitted in M.Tech programme in ECE (VLSI & Embedded System Design) Department bearing Enrollment No. 17205006. He got employment in Air India before completing his M.Tech programme. As he wanted to complete his M.Tech, he has sought permission from the Institute to submit his final year thesis. He has submitted the No Objection Certificate from his Employer for kind consideration

The Senate recommended Mr. Sunil Kumar Yadav to complete his M.Tech by submitting his final year thesis.

5. Application received from Edison Kho and Chandam Thoisona of ECE department for continuation in M.Tech programme. Though the applicants have less than 5 CPI for two consecutive semesters, the DPPC meeting held on 04/09/2019 observed their performance were improving. As per the M.Tech ordinance, they are liable for termination from the course, but seeing their improvement and the career of the students, the DPPC meeting has recommended that they may be allowed to continue the course as a one-time relaxation with issuance of warning to them. The matter is placed for kind discussion.

The Senate permitted for M.Tech programme continuation.

6. Vidya Sagar (16103026) VII semester of CSE department has been placed in McAfee with CTC offering of Rs. 22,000/- during internship per month and Rs. 10 lakhs + Rs. 1 lakh after relocation for full time. As per the condition of the company, he should undergo full time internship for 6 months from January, 2020. It overlaps with the 8th Semester class. The Dean (AA) has put up for 6 months full time internship subject to attending exams and Project Viva of 8th semester at NIT Manipur. The Chairman, senate has approved the proposal subject to ratification in the Senate.

The Senate ratified the proposal.



7. **Discussion on regarding the charges/fees for issuance of transcript, Grade card, Original Degree certificate, Duplicate certificates, duplicate Identity cards, migration certificate, provisional certificate, bonafide certificate etc. Document regarding the miscellaneous fees for the above certificates which have been followed by NIT Manipur since inception on the instruction of NIT Agartala (Mentor NIT)**

The Senate approved the charges/fees for issuance of transcript, Grade card, Original Degree certificate, Duplicate certificates, duplicate Identity cards, migration certificate, provisional certificate, bonafide certificate etc. which is attached at Appendix-1

8. **Discussion on the issue of Co-Supervisor of Pinky Khundrakpam (18405003), Ph.D scholar whose date of registration is 30/08/2018. As per the DC recommendation of ECE department, DPPC meeting held on 29/08/2019 recommended Dr. Biraj Shougaijam, Assistant Professor, Manipur Technical University as the Co-supervisor of Pinky Khundrakpam.**

The Senate did not permit for the nomination of Co-Supervisor of Pinky Khundrakpam (18405003), Ph.D scholar as the experience of guiding PhD by MTU faculty is Nil and doesn't expect benefits from faculty of different research interest.

9. **Discussion on cancellation policy of student's candidature from the Institute. There are cases when students of B.Tech, M.Tech, M.Sc and Ph.D) after getting admitted in the 1st semester apply for cancelling their candidature from the institute asking for full refund of their Fees deposited in the institute. Actually from the point of view of the institute, the institute is losing seat which could have been allotted to some other student. So, the matter is placed in the Senate for kind discussion and for formulation of policy.**

After threadbare discussion and deliberation, the Senate recommended to refund only the caution money deposited (Refundable) and Mess money (after adjustment).
